What is the overall deductible?	In-network provider: \$8,550 individual/\$17,100 family   Out-of-network provider: \$10,000 individual/\$20,000 family	Generally, you must pay all of the costs from <u>providers</u> up to the <u>deductible</u> amount before this <u>plan</u> begins to pay. If you have other family members on the <u>plan</u> , each family member must meet their own individual <u>deductible</u> until the total amount of <u>deductible</u> expenses paid by all family members meets the overall family <u>deductible</u> .
Are there services covered before you meet your deductible?	Yes. In-network: <u>preventive care</u> ; 1st 3 office visits. In-network: preventive Rx drugs. Vision age 18 and younger - In-network: vision exam and hardware.	This <u>plan</u> covers some items and services even if you haven't yet met the <u>deductible</u> amount. But a <u>copayment</u> or <u>coinsurance</u> may apply. #### Does this plan provide Minimum Essential Coverage? Yes.
