Authorization to Disclose Protected Health Information



Instructions

We understand that you may wish us to communicate with others about your healthcare. Certain information regarding your health is protected by state and federal law to help ensure your privacy. We therefore cannot disclose your protected health information without your written authorization.

If you wish to grant a person or entity legal permission to access your protected health information (for example, FSA or HRA plan claim transactions), please complete the form on the reverse using the following guidelines:

- **Member** is the name of the specific person whose protected health information is to be released.
- PacificSource Administrators (PSA) Member ID: The member should have received a letter with this ID number when they enrolled. You may call Customer Service if you need help locating this information.
- **Employer** is the name of your current employer.
- "Recipient or class of recipients" means the name and address of the person(s) you wish to have access to your protected health information.
- Information related to HIV/AIDS test, mental health, genetic testing, or drug/alcohol treatment: If your health information includes any of these categories, your initials are required on the form to authorize their use or disclosure.
- **Expiration date** is the date you wish your authorization to end. After that date, we do not have your permission to use or disclose your protected health information.
- **Event:** Instead of an expiration date, you may specify an event after which we do not have your permission to disclose your protected health information.
- **Signature/relationship to member:** The person whose protected health information is to be released must sign the form in order for the authorization to be valid. If the person is a minor child, their parent or legal guardian may sign for them. If the person is unable to sign for themselves, someone with their power of attorney may sign for them. In the case of legal guardians and holders of power of attorney, legal documentation must be attached.
