What to know about becoming a *qualified* or *certified* interpreter in Oregon



What is a healthcare interpreter?

Interpreters serve an important role between health providers and patients (and their families). They interpret what is being said from the first language to the second language—and back and forth.



Qualified vs. Certified

The Oregon Health Authority (OHA) Health Care Interpreter Program recognizes two levels of credentialing: **qualification** and **certification**.

- ✓ Both are registered by OHA.
- ✓ Both must complete an OHA-approved 60-hour training program.
- ✓ Both require 24 hours of OHA-approved continuing education (CE) every four years.
- ✓ Certified interpreters get their certification by passing a national exam for medical interpreters.

Submitting the OHA application

Bilingual clinic staff members can begin the process of becoming qualified or certified through an OHAapproved 60-hour training program. Upon receiving a certificate of completion, you're ready to submit the OHA application. When your application is approved

After your OHA application is approved (and you appear on the OHA registry), you will need to fill out our Medicaid Provider Validation Form. It's available at <u>CommunitySolutions.PacificSource.com/Providers/</u> <u>DocumentsAndForms</u>.



Are you currently working for a clinic?

If you're a healthcare employee who also serves as a credentialed interpreter, it helps to know that clinics can be reimbursed for interpreter services by using the **T1013 billing code**.
