Each clinical policy is reviewed, updated as needed, and readopted, at least annually, to reflect changes in regulation, new evidence, and advancements in healthcare.

Clinical Guidelines are written when necessary to provide guidance to providers and members in order to outline and clarify coverage criteria in accordance with the terms of the Member's policy. This Clinical Guideline only applies to PacificSource Health Plans, PacificSource Community Health Plans, and PacificSource Community Solutions in Idaho, Montana, Oregon, and Washington. Background

PacificSource Utilization Management (UM) staff evaluates medical necessity, appropriateness, and efficacy of proposed or provided service requests by utilizing standardized criteria and guidelines that are in accordance with evidence-based standards for physical health (medical), behavioral health, and oral health services which:

- Are recognized nationally, and, for Medicaid, required at the State level
- Reflect community standards of care, when appropriate
- Ensures quality of care and access to needed health care services

Multiple aspects of the criteria or guidelines may be utilized to fully evaluate the services, including inpatient and length of stay criteria. Physical health (medical), behavioral health, and oral health care and services are treated comparably throughout the UM process and consider parity and health equity components in the review and use of clinical policies and sources.

This policy outlines resources used to review a request for medical necessity when there are no standardized criteria or guidelines available.

Commercial, Medicaid, and Medicare

There may be more than one set of criteria available for any given procedure or service. Medical necessity determinations under the applicable health plan benefit are based on a hierarchy of clinical policies and care guidelines (See Related Policy: Clinical Criteria Used in UM Decisions policy for hierarchy of criteria). Criteria from the highest-ranking source available should be used unless otherwise indicated. When there are no standardized criteria or guidelines available, PacificSource will use nationally recognized, evidence-based resources, such as those noted below, which may be used with a Third Level Reviewer (e.g., Medical Director, BH Medical Director, or practitioner designee) review.
